Overview

The Brock University Campus Plan is an important tool that will guide the University's growth and change over the next 30 years. The plan demonstrates how growth will be accommodated in a way that supports the University's image, academic goals and financial plans.

Part I of the Campus Plan describes the vision that guided its preparation, setting the stage for the eight principles and foundations and the eight primary initiatives. The principles and foundations reflect the priorities of the University community and its neighbours. Following from these are the primary initiatives that will define the structure of the campus and provide a consistent, attractive and logical system of pedestrian and vehicular routes, infrastructure networks and open spaces that will strengthen and support important places on the campus as it continues to evolve and change.

Part II of the Plan is intended as a reference and operations manual. As such, it defines the land use and design parameters to be followed in the construction and maintenance of the campus landscape and buildings. Part II contains overall policies for the location of different uses on the campus and the role of significant places, outlines design guidelines for campus infrastructure and open spaces and provides detailed guidelines for specific development parcels.

Part III of the Brock University Campus Plan provides policies and recommendations to guide its implementation. It outlines a process for regular review of the plan to ensure that it remains relevant to the University over the 30-year planning horizon. A process for project development and review is recommended as a means to ensure individual projects support the realization of the vision contained within the Campus Plan. Part III of the plan concludes with policies intended to provide for investments in the overall quality of the campus landscape and open spaces.
