<p>1. A minimum 65 percent overall average in RECL 1P90 and 1P99 is required to continue as a major in Recreation and Leisure Studies.</p> <p>2. At least four elective credits (excluding context credits) must be taken outside of the Department of Recreation and Leisure Studies.</p> <p>3. Admission to year 4 (honours) requires a minimum 70 percent major average, and a minimum 70 percent non-major average. Students must submit an application for year 4 studies by July 1.</p> <p>4. Students in the outdoor recreation honours program are strongly encouraged to take both RECL 3Q07 and 3Q17.</p> <p>5. Students in the honours program are strongly encouraged to take RECL 3P95 and 4P77</p> <p>6. Students interested in receiving credit for extended outdoor recreation field experiences must contact the Department. Certain restrictions will apply.</p> <p>7. Students in Therapeutic Recreation are required to supply the following documentation prior to clinical placements: (a) police record check, with a vulnerable sector screening (vulnerability screening can take up to two months), (b) proof of immunization, and (c) TB test. It is the student's responsibility to ensure the process is complete at his/her expense. A mask fit may be required. The student may not be allowed to attend placement if these requirements are not met. Documentation due August 1.</p> <p>8. In 20 credit degree programs a maximum of eight credits may be numbered 1(alpha)00 to 1(alpha)99; at least three credits must be numbered 2(alpha)90 or above; at least three credits must be numbered 3(alpha)90 or above; and the remaining credits must be numbered 2(alpha)00 or above.</p>
