Scientific Research and Experimental Development Program (SR&ED)	The SR&ED program is a federal tax incentive program to encourage Canadian businesses of all sizes and in all sectors to conduct research and development (R&D) in Canada that will lead to new, improved, or technologically advanced products or processes. The SR&ED program is the largest single source of federal government support for industrial research and development.  Work that Qualifies for this credit:  1. Basic Research  2. Applied Research  3. Ontario Interactive Digital Media Tax Credit	The OIDMTC is a refundable tax credit available to qualifying corporations for expenditures related to the creation of eligible interactive digital media products.  A qualifying corporation is a Canadian corporation (Canadian or foreignowned), which develops an eligible product at a permanent establishment in Ontario operated by it, and files an Ontario tax return.  Corporations that are prescribed laboursponsored venture capital corporations under the regulations made under the Income Tax Act (Canada) and corporations that are exempt from tax or are controlled directly or indirectly by a corporation exempt from tax are not eligible for the OIDMTC.	A 40% tax credit is available for eligible Ontario labour expenditures and eligible marketing and distribution expenses incurred by qualifying corporations that develop and market their own products (known as "non-specified products"). The credit is 35% on eligible Ontario labour expenditures for products developed under a fee-for-service arrangement (known as "specified products"). A 35% credit on eligible labour expenditures is also available to qualifying digital game corporations and specialized digital game corporations (see large digital game corporations below). Undergraduate Student Research Awards (USRA)  Natural Sciences and Engineering Research Council of Canada (NSERC)	National Sciences and Engineering Research Council of Canada, provides grant money to hire students, to companies engaged in R&D activities based on technology derived from engineering.  Applications for Undergraduate Student Research Awards (USRA) must be completed and submitted to the Canadian university where you wish to hold an award through NSERC's On-line System. Selected applications are submitted to NSERC by universities. No applications for university awards may be submitted directly to NSERC. Youth-Green  National Research Council Industrial Research Assistance Program (NRC-IRAP)	The Youth Employment Program-Green (Youth-Green) is a program geared to help support SMEs in the hiring of Youth where the firms' sector or industry is linked (directly or through client base) to a green economy, or, where the job requires a specialty and technical skills to produce an environmental benefit.  NRC-IRAP reimburses up to 100% of the total supported Salary Costs for the Youth up to a maximum contribution of \$10,000 per Youth, which reimburses a portion of the Youth's salary. Salary costs for a Youth exclude benefits, incentives and bonuses but can include statutory holidays, sick leave and vacation pay. No other costs are supported by NRC-IRAP's Youth-Green.	The duration of NRC-IRAP's Youth-Green internship must be a minimum of three (3) months to a maximum of six (6) months. The Youth must be hired as a full-time employee (30+ hours per week) for the duration of the internship. Consideration will be given for part-time employment in special circumstances (persons with disabilities, etc.). The Youth must be on the firm's payroll and must receive a T4 for income tax purposes.
