

### NEW BOOK:

*Feminist Reconfigurings of Alien Encounters  
Ethical Co-Existence in More-than-Human Worlds*  
By Nina Lykke, Katja Aglert, Line Henriksen



Feminist Reconfigurings of Alien Encounters reclaims the notion of alien encounters together with strange but queerly loved companions: Vulgar slugs, diatoms (micro-algae), and familiars (spirit guides of witches). The book's three human co-authors ask: what would it take to establish more-than-human, bio- and geo-egalitarian co-existence on a planet in trouble?

This playfully crafted mixed-genre book is informed by feminist posthumanisms and co-created with a spectral community of more-than-humans who are respectfully summoned to contribute with their perspectives. In focus of the entangled artistic-philosophical-poetic investigations are questions of ethics, aesthetics, and methodologies to co-exist response-ably rather than based on modern human beliefs in exceptionalism and entitlement to sovereignty, control, and conquest of more-than-human worlds.

## CALL FOR PAPERS

For a Session at College Art Association's 113th Annual Conference

### **Urban Artscapes and the Urbanocene**

The Anthropocene discussions often focus on the so-called “great acceleration” which underestimates the effective role of urbanization and the geographic, economic, social, cultural and political upheavals accompanying it. Urbanocene, which is widely discussed by scholars Geoffrey West, Massimo Palme, Agnese Salvati and Daniele la Rosa, situates the great acceleration of the late XX Century where it takes place: cities and urbanization. This session discusses the radical strategies employed by artists in navigating the Urbanocene by metamorphosing urban public spaces into vibrant arenas of introspection, advocacy, and resilience. Through a multifaceted examination of urban artistic praxes encompassing installations, murals, public art and interventions, this session scrutinizes the manifold modalities through urban vistas as conduits for discourse on ecological imperatives, heralding advocacies for radical ecology, preservation of biodiversity, and the pursuit of climate justice. Can the catalytic potential of these artistic endeavors galvanize urban communities' involvement and nurture a sense of symbiosis within the urban environment? This session provides a platform for interdisciplinary dialogue and exploration of the transformative power of urban art within the context of the Urbanocene.

We search for papers that explore:

- Urbanocene paradigm and its implications for the urban artscapes
- The potential of public art to galvanize collective action toward sustainability and ecological justice.
- Case studies of transformative artistic interventions in the urban space inspired by new materialism and posthumanism.
- Artistic strategies cultivating ecological consciousness and mobilizing urban communities.


Selected papers will be invited to contribute to the edited book by the book series "Posthumanities and Citizenship Futures" of Rowman& Littlefield.

This double issue (of which the second part will be released later this year) rethinks and reconceptualizes the (im)material, affective, and digital manifestations of violence by means of Deleuzoguattarian, critical posthumanist, and related perspectives.

### APOCALYPTIC THINKING IN THE ANTHROPOCENE

What are the cultural politics of apocalyptic thinking? What movements, politics, ideas, geographies, sensibilities, stories, and images might be considered (post)apocalyptic or invoke debates and feelings about the end of the/a world? What does the concept of anthropogenic violence do to an understanding of the world, its various endings, and possible aftermaths? How does the notion of apocalypse shift (or substantiate) hegemonic understandings, inevitable interpretations, or false hopes in a purportedly doomed and unpredictable world? What kind of temporalities, spaces, affects, and practices are intimated (or troubled) by the apocalyptic? And in turn, how do present, past, and current endings inspire a rethinking of apocalypse itself? How does apocalypse help us to address escalating global as well as local challenges which (also) articulate the promise of diverse futures and (perhaps) more just, political commons, alternative collectivities, and fuller relationships with each other and the world?

We are seeking original submissions that actively explore apocalyptic thinking (and its associated imaginaries, experiences, practices, forms, aesthetics, genres, affects, fantasies, themes, etc.) in order to unpack these (and other) questions and concerns.

**The Institute of Philosophy in Bern invites applications for a 4-year fully funded postdoc position in feminist philosophy of climate science, starting 1 September 2024 (or as soon as possible thereafter).**

The position is funded by the Swiss National Science Foundation through Prof. Julie Jebeile's SNF PRIMA Grant project "Climate Change Adaptation through the Feminist Kaleidoscope - Toward a Feminist Philosophy of Climate Science". The salary is competitive. Travel and further research funding

The selected candidate will also be affiliated with the Oeschger Centre for Climate Change Research which constitutes a great opportunity for fruitful interdisciplinary collaborations.

### Requirements:

- To hold a PhD in philosophy; the PhD must be in hand from the start of the position
- To have a background in feminist epistemology
- Ideally, to have skills in one or more of these domains: philosophy of climate science, epistemology of Indigenous and local knowledge, climate ethics, environmental philosophy, climate science
- To have excellent skills in English
- Applications from underrepresented groups in academic philosophy are of course strongly encouraged.

Two reference letters are expected and should be directly sent by the referees. Review of the applications will start on **15 April 2024** and will continue until the position is filled. Interviews will take place online.



The questions that posthumanism raises, of what it means to be human, the nature of our relationship with the world, our relative importance, our obligations, entanglements, potentials and limitations, speak to every aspect of life. This series will address questions such as: What are the implications and entailed effects of the revelations of contemporary science and philosophy? Can our laws, societies, and egos hold up to our becoming less special? What can we do, and how might thinking differently enable us to act differently?

Works in this series will pose these kinds of questions and offer practical answers, suggestions and provocations. The aim is to inspire work that isn't occurring often or loudly enough, and to promote a wide variety of voices which are left outside of the arenas where they might be most usefully heard. Disciplinary conversations also often remain siloed, but posthumanism is inherently an interdisciplinary concern; the field questions (but doesn't necessarily reject) the usefulness and stability of existing disciplinary boundaries. As such, this series will prioritize works which bring insights across those boundaries and which demonstrate the real-world potential and/or risks of posthumanist ideas.


