REPORT OF THE ACTIONS OF THE UNIVERSITY SENATE

The meeting of the 682nd meeting of Senate was held on September 16, 2020. The Agenda and materials for this meeting are available by clicking <u>HERE</u>. During the meeting, Senate undertook the following actions:

- received a memorandum from the Provost and Vice-President, Academic, and
 - approved that:
 - the Provost and Vice-President, Academic, in consultation with the President and Vice-Chancellor, be authorized to mandate that the Winter 2021 term be delivered predominantly through online or alternative delivery methods; and
 - 2. the University Registrar be authorized to adjust restrictions or programming for the Winter 2021 term as needed, without modifying the Academic Calendar, related to the following items:
 - a. contact hours;
 - b. notes referencing the delivery mode (i.e., onsite, online, or blended learning);
 - c. prerequisite requirements as they relate to year 1 courses and sequencing; and
 - d. experiential education components of courses; provided that such adjustments be undertaken in consultation with Departments, Centres and Programs, coordinated by the respective Faculty Deans
