REPORT OF THE ACTIONS OF THE UNIVERSITY SENATE

The <u>685th meeting of Senate</u> was held on December 16, 2020. The <u>Faculty Handbook</u> has been updated to reflect any approved policy changes. During the meeting, Senate undertook the following actions:

 - authorized the University to extend its emergency acceptance of the Duolingo test to satisfy Brock's EPT requirement. The required minimum Duolingo score is 110. The Co-op Accounting program will require a Duolingo score of 120.

 - approved that Section 2 of the Faculty Handbook be amended to update references to administrative position titles as outlined in Appendix 1 of the Report
 - approved that Faculty Handbook 2: 9.1.1 be amended to provide clarity surrounding ex officio members' status in quorum at meetings of Senate's committees as follows (strike-out indicates deletion; highlight indicates addition):
 - 9.1.1 Quorum
 - 9.1.1.1A quorum for a Senate committee shall be one-half of its membership (excluding BUFA observers). In accordance with FHB II: 9.1.3, tThe Chair and Vice-Chair of Senate shall not be counted when determining quorum for Senate committee. A committee may proceed with its agenda with only 30% in attendance provided that the agenda has been circulated in accordance with FHB II: 9.1.6 A and its decisions will be ratified at a later full-quorum meeting in advance of being forwarded to Senate.
