

## REPORT OF THE ACTIONS OF THE UNIVERSITY SENATE

A <u>meeting of the 2024-25 Senate-Elect</u> and the <u>720<sup>th</sup> meeting of Senate</u> were held on May 8, 2024. The <u>Faculty Handbook</u> has been updated to reflect any approved policy changes. During the meeting, Senate undertook the following actions:

- during the meeting of Senate-Elect
  - approved that Senator Braley-Rattai be elected as Chair of the Governance Committee for a two-year term ending 2026
  - approved that Senator Hauck be elected as Vice-Chair of the Governance Committee for a two-year term ending 2026
  - approved that Senators Carpenter-Cleland, L. Savage, Malleck, Blayer, El-Hoss, Hands, and Professor Elayan be elected as members of the 2024-25 Governance Committee
- defeated a motion to waive the Five-Day Rule and accept a late posted report from the Teaching and Learning Policy Committee
- reviewed a Report from the Graduate Studies Committee, and
  - approved that Faculty Handbook Sections III: B. 9. 4 (Thesis Defences) and 10.2 (Evaluation of Theses, Projects and Major Research Papers) be revised as outlined in the attached appendices to the Report
