Pre-appeal procedure: A student who wishes to appeal a matter listed below must first submit their request to the decision maker listed under '1st recourse'. If the student is not satisfied with the decision of the decision maker, the student may appeal to the next level of recourse. Appeals must include all forms, documents and decision letters from previous level(s) of appeal.

Appeal timelines: Appeals must be submitted to the decision maker listed under '1st recourse' by the appeal submission deadline listed below. Where there is no applicable deadline, appeals must be submitted prior to graduation.
