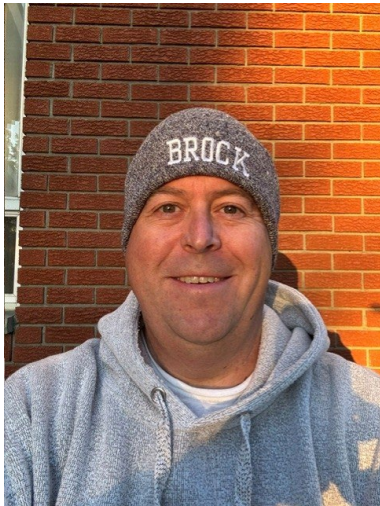

Brian Lang was appointed Chief Executive Officer of Real Matters and joined its Board of Directors in November 2020. Mr. Lang joined Real Matters as President and Chief Operating Officer in June 2019. Prior to joining Real Matters, Mr. Lang was President of MasterCard Canada. Lang's career with MasterCard spanned more than 13 years during which he held a number of senior executive positions in various geographies including Europe, Eastern Europe, the Middle East, Africa and Canada. Prior to MasterCard, Lang held key management roles with CIBC and Aeroplan. Mr. Lang is a graduate of the University of British Columbia with a Bachelor of Arts and he is a Six Sigma Master Black Belt. Previously, the forest ecologist and biogeographer led the research enterprise at Western University as the institution's Vice-President, Research. Prior to arriving at Western, she served as Dean of the Faculty of Science and Professor, Biological Sciences at the University of Calgary, where she led one of the largest Faculties on campus spanning six departments and five multidisciplinary programs. Her experience also includes significant leadership at Northern Illinois University. There, she served as Vice-President for Research and Innovation Partnerships and other roles including Associate Dean Research and Graduate Affairs in the College of Liberal Arts and Sciences.
