CPCF will discuss the possibility of cross listing Indigenous Perspectives in the Media (INDG 3P85) at an upcoming meeting or our annual retreat.

This recommendation is most applicable to the Film Studies program, has been addressed in a Film Studies retreat and will be submitted to UPC for change in October 2023. We are hoping to fast-track changes to our Minor before registration this Spring.

Comments 2024:

Film Studies introduced several UPC changes in 2024 to streamline the degree offerings. The number of specified required courses in Year 2 was reduced from six to five (or 3 credits to 2.5), and the remaining half credit was added to the list of possible courses from which students may choose. A required second year course was shifted to third year, and the overall number of specified required courses in Year 3 was reduced from five (2.5 credits) to two (1 credit). Those previously required courses were shifted to the list of possible courses. The number of credits from this bank of courses was accordingly raised from 1 to 2.5. Students in Year 3 are also now allowed an additional 0.5 elective credits. The requirements for a Film Studies minor were eased up by shifting four specified required courses (2 credits) to the wider bank of possible courses from which they may draw (now 3 credits). Additionally, certain prerequisites for a number of courses were removed.

Recommendation #4

Create capstone courses for CPCF programs.

ARC considers the recommendation to be accepted and in the process of implementation. The Committee recognizes that the Department will consider creating capstone courses in the context of a larger discussion about curriculum.

While definitions of capstone courses differ, we believe this recommendation was satisfied by our calendar revision to CPCF 4F00, which now better reflects the educational component of the course, rather than just the placement. This change was passed during our October 2022 Departmental Council meeting.

Comments 2024:

CPCF believes that the Department's 4F00 course - Placement in Communication, Popular Culture or Film – excellently fulfils a capstone course opportunity for CPCF students. Note the following Calendar overview:

Application of course theories, knowledge, and core concepts to workplace experience. Synthesis and reflection of prior learning. Part-time placement related to communication, popular culture or film in a company, agency, or not-for-profit organization. Students are responsible for arranging their own placements in consultation with the department Academic Adviser and Experiential Learning Co-Ordinator. Lectures, 160-hour placement.

The viability of the Popular Culture (PCUL) major has long been a concern. In the recent past, we eliminated the Masters in Popular Culture. However, many undergraduate courses in Popular Culture attract students, even though the major does not. This history and newer concerns will inform this upcoming discussion of program viability.

Comments 2024:

The viability of the Popular Culture (PCUL) major is currently being reviewed as part of the program viability process. CPCF has indicated that we would like to discontinue the PCUL major and focus on revising the PCUL minor and concentration (with a possibility for PCUL micro-credential). We created a committee to act upon this decision.

Recommendation #6

Improve condition and repair of classroom technology for film/media courses.

The lessening of pandemic restrictions seems to have encouraged faculty to present research. CPCF is promoting research completed by colleagues via the FOSS newsletter and Research Symposium Series as well as via CRISS. We will also invite a delegate from ORS to a Departmental meeting in the 2023-24 year, to discuss funding opportunities that can support our graduate students once the graduate program is closer to starting.

Comments 2024:

CPCF scholars have had an impressive year of securing funding and publishing research. For example: Dr. Duncan Koerber et al.'s recent article, The Role of Municipalities in Communicating for Community Resilience during the COVID-19 Pandemic: A Study of Niagara Region's Crisis Communication, in the Canadian Journal of Communication; Dr. Russell Johnston's co-authored book with Dr. Michael Ripmeester, Meaningful Pasts: Historical Narratives, Commemorative Landscapes, and Everyday Lives; and Dr. Michelle Chen's just published article Dual Impact of Tie Strength and Visibility of Action on Political Participation Types in the International Journal of Communication. These successes, amongst a number of others including securing funding, have continued to be widely shared via departmental and FoSS university platforms and social media platforms.

Recommendation #8

CPCF should expand their support of student-focused extracurricular events.

Supporting text: ...CPCF could apply for a student ambassador for social events, rebounding from Covid isolation.

Comments 2024:

CPCF was very pleased to be able to hire two Student Ambassadors who were involved with hosting a variety of in-person and online student events. The CPCF Student Society once again hosted the 72-hour Film Festival with excellent student participation and a very well attended screening at the Film House. Our inaugural Campaign Challenge engaged students in a brand crisis situation. Student teams competed, while fellow students helped run the event alongside alumni who returned to judge the competition. CPCF also had four Student Representatives who attended department meetings and was part of outreach events.
