As in 2022, the Department continues to engage in ongoing discussions with the Dean and Provost on the allocation of resources, departmental priorities and priority hirings. The Department has also submitted an application to the University for the approval of a Canada Research Chair position focused on climate change and climatology and was also recently granted funding via the Dean's Discretionary Fund to engage in a comprehensive study of physical geography programs at other universities across Ontario in order to identify departmental strengths and opportunities for differentiating the Brock program from others.

Comments 2024:

GTS continues ongoing discussions with the Dean and Provost on the allocation of resources, departmental priorities and priority hirings. In March 2023 the Department also submitted a new proposal for a Tier I Canada Research Chair position that would focus on climate change and climatology.

In order to advance a more coherent university-wide strategy on sustainability, we recommend:

- a) A dialogue and internal review on how the sustainability dimension of [the] university strategic plan can best be achieved through campus-wide collaboration.
- b) That the university conducts campus-wide sustainability curriculum mapping to identify duplication and areas of synergy. With support from Senior Administration, GTS could lead this exercise.
- c) That GTS be a core hub for sustainability as a more-encompassing unit. GTS can bring together other contributing units as well (e.g., ESRC [Environmental Sustainability Research Centre], Earth Sciences, Health Sciences, Goodman School of Business, new Engineering minor, and others).

ARC Disposition of the Recommendation

ARC considers the recommendation to advance a university-wide strategy on sustainability to be beyond the scope of this review. The Committee recognizes the opportunity for collaboration between the Department and sustainability stakeholders across the university and the support indicated by the Deans in their responses to the recommendation. The Tourism Committee has met several times since we received the Final Assessment Report. In Fall 2022 the Department will be submitting a Request for Major Modifications to change the name of the degree from a BA in Tourism and Environment to a BA in Sustainable Tourism. Two Concentrations will also be added (Concentration in Management and Concentration in Planning and Development).

Comments 2023:

The Tourism Committee continues to work on implementing this recommendation; however, the process has been delayed with two of the five Tourism faculty members being on a one-year Sabbatical Leave from July 2022 to June 2023 and a third being away for our Term Abroad Program in the Winter Term of 2022-2023. The Department now anticipates submitting its full Request for Major Modifications to ARC by the end of Summer 2023.

Comments 2024:

The Tourism Committee continues to work on implementing this recommendation; although a Request for Major Modifications was planned for submission in the Summer of 2023, this was delayed for various reasons. The Department now anticipates submitting its Request to ARC by the end of Summer 2024; this will follow a two-day departmental retreat in which we will be re-examing (1) the structure of our undergraduate programs and (2) the future of our MA Geography graduate program, which has been paused for the 2024-2025 academic year.

Plans to develop a new Masters in Tourism program should be put on hold for now.

Comments 2022:

The Department of GTS is currently working with Brock's Transfer Pathways Specialist to develop a collaborative program with Fleming College's GIS program and Durham College's Tourism programs. We also plan to further discussions with Niagara College's Tourism and Hospitality program.

Comments 2023:

The Department has made significant progress in this regard and expects its first new collaborative program to be implemented in the near future. Other discussions are ongoing.

Comments 2024:

Discussions are ongoing regarding collaborative programs in Tourism. As noted earlier, the articulation agreement with Fleming College did not go through, as Fleming College has paused their GIS program for at least one year.

GTS should undertake a comprehensive review of its field courses as outlined in greater detail below.

Supporting/Clarifying Text from Reviewer's Report

Field/excursion courses are a core element of both geography and tourism studies and consistent with the university Strategic Plan priority of internationalization. We offer the following recommendations related to the challenges of offering consistent international experiences:

- a) Review the suite of field/excursion courses and the related requirements by the Geography and Tourism Studies programs. Consider allowing students more flexibility to choose from a cluster (i.e., 'one of') of field/excursion courses to fulfill any related requirements to address student concerns about the appropriate fit of the Peterborough course, and potentially help achieve the threshold of enrollment for international field courses more often.
- b) Establish dialogue with other academic units at Brock that are conducting field courses and explore integrating inter-disciplinary groups of students that can be travel to the same destination with different but related educational experiences.
- c) Discuss the potential development of a new field course in collaboration with the new Canada-Caribbean Institute and its diverse regional partners.
- d) Consult with the Dean about a reliable budget allocation for 1-2 courses per year, and/or also potential arrangements to support early deposits needed to arrange travel and accommodations to lower the price that students eventually pay, should and potential increase early enrollments.
- e) Consult with the Dean about potential flexibility in class minimums for international field courses.

The Field Course Committee in GTS reviews our commitments to field course offerings annually. The Tourism Committee also recognizes the need for a separate field experience for Tourism majors. A new field course leveraging our proximity to tourism destinations in Niagara will be presented along with other proposed program modifications, which will be submitted to ARC in Fall 2022. The Dean of FOSS has also initiated a two-year pilot program to provide funding for students participating in extra-local and international field experiences that GTS offers.

Comments 2023:

A new field course leveraging our proximity to tourism destinations in Niagara will be presented along with other proposed program modifications, which will be submitted to ARC in Fall 2023. The Dean's financial assistance to students wishing to take part in field courses (including Vancouver and Croatia) has been highly successful and have helped considerably to increase student demand for these experiential learning opportunities. Field courses to London (U.K.) and Vancouver for 2024 are currently under development.

All recently developed Minor program offerings in GTS were approved by the Dean of FOSS, UPC, and Senate after we consulted with other academic units in selecting the required and elective courses. All recent Minors were developed with the knowledge that we would rely on contributions from other units to fulfill some of the requirements.

- c) Exploring options to offer 0.5 courses in a condensed format not just in Spring/Summer but in the Fall/Winter as well (there are several examples such as super-courses that run for one week or two, intensive courses that run for 6 weeks); or even schedule course more flexibly (evening, weekends);
- d) Allowing students to take UG courses from other universities through LOPs (letter of permission) either online or in person;
- e) Avoid cancelling UG courses due to low enrollment, which creates domino-effects for students and disruptions for faculty members;
- f) Establishing agreements with other interested stakeholders within Brock (Transdisciplinary centres, Canada Games, Indigenous Studies, Canada-Caribbean Institute, Health Sciences) and outside (Centennial College) to find additional Co-op placements for students.
