Comments 2022:

A student was hired in 2021 to carry out research on graduate certificate/diploma programs in Ontario primarily, and across Canada. A report was created and will be discussed at the SJES AGM in May 2022. Micro-certificates are also being discussed at the Faculty of Graduate Studies Council and will also be discussed at the SJES AGM in 2022.

Comments 2023:

SJES decided at the 2022 AGM to wait for guidance from the Faculty of Graduate Studies and see how micro-programs were being developed and implemented. It will be discussed again at the AGM on May 18, 2023.

Comments 2024:

The program consulted with its faculty affiliates at the AGM in May 2023 and many issues were discussed, such as having a negative impact on current course experiences, diploma/certificate as fund generators for the university, etc. It was decided after this consultation to not implement a graduate certificate/diploma at this time. NOTE: Consideration of the recommendation is the completed action.

Increase funding for graduate students to participate in conferences and other events.
